



In accordance with the Instructions to Bidders Clause 7 of the Bidding Document for the “Upgradation of Krishna Chowk – Community Forest Road, Utlabari, RFB No: NP-DUDBC NP-DUDBC-273143-CW-RFB”, queries submitted by the bidder(s) are listed below. The clarifications for all queries are also presented in tabular format hereunder:

1	Section III Evaluation & Qualification Criteria NO: 4.2 (C) Specific Experience in managing ES aspects: what works are considered under the ESMP/C-ESMP and the ESMP work alone has to be worth USD 1 Million.	The road construction/improvement contracts having contract value of USD 1 million or more, substantially implemented/completed with Environmental and Social Management Plan (ESMP)/ Contractor’s Environmental and Social Management Plan (C-ESMP) will be considered.

Moreover, considering the probable lapses in preparing bids by the potential bidders, the Employer would like to clarify and draw bidders’ attention to consider following points:

1. Complete clause (d) ‘Sexual Exploitation and Abuse (SEA) and/or Sexual Harassment (SH)’ in the Letter of Bid (Section IV - Bidding Forms) by ‘selecting the appropriate option from (i) to (v) and deleting others’, with respect to the submission requirement of 2.6 Bank’s SEA and/or SH Disqualification (Section III - Evaluation and Qualification Criteria).
2. Complete Form CON – 4: ‘Sexual Exploitation and Abuse (SEA) and/or Sexual Harassment Performance Declaration (Section IV – Bidding Forms)’ by selecting the corresponding option as above with respect to the submission requirement of 2.6 Bank’s SEA and/or SH Disqualification (Section III - Evaluation and Qualification Criteria).
3. Also complete the documentation of Bid as per the “Submission Requirements” of table D. Qualification (Section III - Evaluation and Qualification Criteria).
4. Submit the required documents as per the Bidding Document and avoid multiple entry/duplication of the same pages/document in the submission.
