- 2. Sealed bids must be submitted toUrlabarimunicipality, office of the municipal executive, urlabarimorang on or before 12:00 noon on 2077/02/14(27th May2020). Documents received after this deadline shall not be accepted
- 3. Bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 on 2077/02/14(27th May 2020) at the office of UrlabariMunicipality,Urlabari, Morang. Bids must be valid for a period of 45 days after bid opening and must be accompanied by bid security, which shall be valid for 30 days beyond the bid validity period.
- 4. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security, which shall be valid for at least 30 days beyond the validity period of the bid after the date of bid opening.
- 5. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 6. The Employer reserves the right to accept or reject any bid, and to annul the process and reject all bids at any time prior to contract award.
- 7. Other related rules and regulations are as per current Public Procurement Act and Regulations with latest amendment.
